## **Joy Becker**

I am an Associate Professor of Aquatic Animal Health and Production at the University of Sydney. I hold a Bachelor of Science in Zoology from the University of Western Ontario (Canada) and a Doctor of Philosophy in Fish Health from the Atlantic Veterinary College (Canada).

Fish are my passion! My teaching and research program centres around various fish species and their preservation in natural habitats, aquaculture settings, and as companion animals. I specialize in researching aquatic pathogens that threaten wild populations and investigating pathogen transmission between farmed and wild fish. My expertise spans cold to tropical waters, freshwater, brackish, and marine environments, encompassing a diverse range of fish species with both conservation and economic significance. My research program has a strong industry focus on "real world" problems faced by fish farmers.

I have an energetic determination to make meaningful contributions to society through research and teaching that will promote the sustainable production of fish whilst limiting the impact of diseases. My career goal is to establish and mentor a collaborative network of innovative scientists that share a goal to find industry-relevant solutions to global problems in aquaculture through education and research.

This is vital for human and animal health and for food security as there is an ever-widening gap between the global demand for seafood and the limited supply from the wild fisheries. I use my research as a way to connect with students and relate theoretical content to real world problems.

I am recognized as a national leader in aquaculture and fish health and disease as an expert media adviser. Increasing scientific literacy in the public and inspiring young people to get into STEM subjects is a passion of mine. I am regularly asked for interviews on topics related to fish (e.g. National Carp Control Plan, NSW fish kills; with 5-8 requests pa; as recent as March 2023). I have contributed numerous interviews for local and national tv (SBS, ABC, 7 News), radio (ABC, The Conversation Hour) and print media (Sydney Morning Herald, The Land, ABC). As an example, an interview with ABC news regarding the fish kills in western NSW in March 2023 was shared and broadcasted on 241 international media outlets.

Further, to encourage kids to study STEM disciplines, I have appeared on children's tv show (Channel 7; Get Clever) and have hosted high school student groups in my lab for university open days.

Following a world-wide search, I was named co-founding Editor in Chief of the international peer reviewed journal <u>Aquaculture</u>, <u>Fish and Fisheries</u> published by Wiley (2021-current). The scope of the journal is intentionally broad, and we have a particular focus to support multi-disciplinary approaches, female authors, and authors from developing countries. AFF has published 10 issues, listed on the Directory of Open Access journals. To support the development of early career academics, with my co-editor in chief, we have established a junior editorial board to provide editorial experiences and mentoring.

I am recognized as a University leader in agriculture and food. Today, there are no female professors in agriculture and food in the School of Life and Environmental Sciences. Looking

more broadly across the University of Sydney (ranked 19<sup>th</sup> in the world), I there are only 2 female professors in this area!

I want undergraduate and post graduate students and the community to see women as senior leaders in agriculture/primary production and food teaching and research programs. I make sure that I am visible to prospective high school and undergraduate students by attending open day and by teaching across Years 1 to 3 and to the community by engaging with media.

Women are a third of the agricultural workforce in Australia, although the true contribution is estimated to be higher because of the substantive amount of unpaid work provided by women (ABARES).

My application for the WISA board is highly motivated by these goals:

- My goal is to empower women to move past supportive roles to take on decisionmaking positions in agriculture/primary production to bring diversity and equality to our rural economies.
- My goal is to support and inspire more girls and women to get involved in fisheries and aquaculture as their career, sport, and special interest area! I do this by being visible and present.

I am nominating for the NSW position because I feel that my strengths are:

- Experience in governance and ensuring compliance across various codes of practice
- Facilitating shared goals of colleagues to advance the organization
- · Affinity for administration and well-refined organizational skills
- Superior skills in data analytics and project management
- An international research leader in my discipline
